FIRE BREAKS AND UNTIDY PROPERTIES

The deadline for having your firebreaks in place for this bushfire season was 1 October. Shire staff and our contract Ranger have been checking properties and should you not be complying with the Shire's Fire Break Order, you may be subject to penalties prescribed in the *Bush Fires Act*, 1954.

All town site lots within the Shire of Mt Marshall shall be cleared of all debris of an inflammable nature and be maintained free of such material. Debris could include long grass, dead trees/branches, or disused wood. Importantly, if your firebreaks are not compliant it may affect your insurance.
