### **Summary of question from Mrs Michelle Kirby:**

Regarding Officer Recommendation 1.1 (i) that the General Practitioner (GP) hold a clinic at Beacon for half a day a fortnight for a trial period of six (6) months to establish whether the clinic was sustainable for the GP;

As President of the Beacon Branch Silver Chain Committee and Ratepayer of the Mt Marshall Shire I would like this statement to read "that the General Practitioner (GP) hold a clinic at Beacon for half a day a fortnight" PERIOD!

It should not be a matter of whether the GP feels coming to Beacon is profitable, from what I ascertain the whole practice is subsidised - so whether it is Beacon or another part of the practice should not discriminate.

The Beacon & surrounding residents (ratepayers) should have access to a Doctor. If our Shire is supporting the practice, then coming to every town should be a given - even more so to the areas further away from the hospital I would have thought. Could we please adjust the 1.1 of the recommendation?

### **Summary of response from the Presiding Member:**

At the most recent Kununoppin Medical Practice Committee (KMPC) meeting, the Mt Marshall representatives advocated strongly to retain a service in Beacon. This service is under threat due to the concerns raised by service providers about the number of patients attending the clinic. The Shire is advocating that the current service level be retained and intends to promote the service to the Beacon community, emphasising the importance of community support during this trial period.

The issue is if the GP refuses to go to Beacon then Council needs to direct its Representatives on whether to continue with the Bencubbin service only or to withdraw. To withdraw would mean even further for Beacon residents to travel (Mukinbudin or Kununoppin).

### **Summary of question from Mr Noel Miguel:**

With the ratepayers across the whole Shire expected to contribute \$1.332 million dollars to the proposed Bencubbin Multipurpose Complex, would it not be reasonable to those ratepayers to be informed prior to any agreement or consent to build, to be made aware of effective rate increases and how the specified area rate will actually affect some ratepayers?

#### **Summary of response from the Presiding Member:**

The Shire has received the draft Deed of Agreement from Department of Infrastructure and Regional Development and there is a committee recommendation to endorse the

execution of the Deed. This does not permit time for widespread community consultation on the impact on rates.

Rough calculations indicate that the repayments on a "Whole of Shire" loan of \$432,600 will be around \$30,167 pa which represents 2.5% of the rates income. Although this figure gives some indication of the magnitude of the repayments, it does not necessarily translate to a direct rate increase. This repayment can be financed either by a rate increase or by a reduction in other expenditure in the Shire Budget.

With regard to the specified area rate (SAR), the Shire have received advice that community consultation should be undertaken as part of the overall process of deliberation and consideration required before Council becomes empowered to impose a specified area rate.

### **Summary of question from Mr Chris Kirby:**

With regards to the budget allocations for the Bencubbin Multipurpose Complex there has been some changes to the final monetary allocations. Could you please detail the makeup of these?

### **Summary of response from the Presiding Member:**

As a result of negotiations with NSRF on the budget that was submitted subsequent to the December 2015 Ordinary Council Meeting, some minor changes were required.

- A) National Stronger Region Funding (NSRF) has decreased by \$15,000 to \$917,400 due to \$42,400 of Bencubbin Community Recreation Committee (BCRC) in-kind not being eligible for matching funding.
- B) The amount of \$100,000 that was previously "Shire in-kind" was added to the loan total as this will now be funding new salaries for management of the project rather than "in-kind" of existing salaries.
- C) An amount of \$15,000, was added to the Shire loan total to make up the shortfall in NSRF funding.
- D) The balance of the Shire loan total comprises \$317,600 "Whole of Shire Loan" and \$550,000 unallocated.
- E) An amount of \$100,000 that was previously "BCRC in-kind" has been allocated to BCRC loan.

#### **Summary of question from Mr Chris Kirby:**

As the previous Council was removed on the basis of insufficient community consultation and with the finalization of the budget and the allocated fiscal responsibilities, will the ratepayers responsible for the proposed specified area rate be given a chance to vote on whether they wish to take on this commitment?

### **Summary of response from the Presiding Member:**

The Shire has received advice advising that proper community consultation should be undertaken as part of the overall process of deliberation and consideration required before Council becomes empowered to impose a specified area rate.

### **Summary of question from Mrs Megan Beagley:**

What will happen with the draft agreement between NSRF and the Shire and how will it be affected if after community consultation SARs are rejected?

### **Summary of response from the Presiding Member:**

The Presiding Member invited the Acting CEO to respond. The Acting CEO informed the meeting that if the application of Specified Area Rates was rejected Council would have several alternatives. One would be that Council is responsible for the total loans excluding the self-supporting loan of the BCRC, another would be to revisit the design with a view to reducing the specifications and therefore costs or lastly the Shire writes to the Department of Infrastructure and Regional Development letting them know we will have to discontinue the project resulting in giving back any money we have received from the NSRF. All other costs incurred to get to this point in the project will be absorbed by the Shire.

### **Summary of question from Mrs Michelle Kirby:**

Is Council going to do all they can to progress the matter of Doctor Services continuing in Beacon?

### **Summary of response from the Presiding Member:**

This is the first Council meeting since the last Kununoppin Medical Practice Committee meeting and the first chance Council has had to discuss the outcomes of that meeting. As Cr Tony Sachse attended the last KMPC meeting the Presiding Member invited Cr Sachse to address the meeting on this subject. Cr Sachse informed the meeting that the Doctor will be operating as a private practice and as such the Shire of Mt Marshall or the KMPC cannot instruct the practice or the Doctor, and instead can only recommend that the Doctor conducts a trial in Beacon. This could be negotiated with an agreement between the KMPC, the Shire Councils involved and the new Doctor. The Shire has offered support for travel arrangements at KMPC meetings, however was informed it was not an issue to address at this point.

#### **Summary of question form Mrs Marian Kirby:**

Is the Shire aware that the Doctor only allocates two hours for appointments per visit to Beacon and that overflow appointments are directed to Bencubbin?

#### **Summary of response from the Presiding Member:**

Once again the Presiding Member invited Cr ARC Sachse to respond. Cr Sachse informed the meeting that among other issues distance had been discussed at KMPC meetings after this being an issue with previous GPs. The incoming Doctor may not consider this to be an issue. There is seasonal variability in clinic numbers especially during the January summer holiday period. The lack of numbers at January clinics had been mentioned by the previous Doctor. Any determination regarding clinic numbers needs to take into account seasonal variability.

#### **Summary of question from Mr Noel Miguel:**

With the recent tension between the two communities of Beacon and Bencubbin could the Shire explore solutions to mend the rift, possibly with the help of community leaders?

#### **Summary of response from the Presiding Member:**

The Presiding Member informed the meeting that Council has informally discussed this topic and agrees with Mr Miguel, that it would be a good idea to work towards a solution.

## **Summary of Question from Mrs Tanya Gibson:**

Could the Shire please consider amending the Shire's social media policy to restrict comments on the Shire's social media posts?

### **Summary of response from the Presiding Member:**

The Presiding Member informed the meeting that she agrees with Mrs Gibson's sentiments. The Shire's social media sites are a good public relations tool and are used to disseminate positive information. The Presiding Member referred to the Acting CEO who informed the meeting that the Policy Manual is currently under review.

#### **BACKGROUND:**

The Shire of Mt Marshall Club Support Fund is a new initiative by the Shire to provide much needed support and assistance to sport and recreational clubs within the community. A similar scheme called the 'Community Support Fund' was run by the Shire between 2003-2008 and assisted many community projects and events. The Club Support Fund aims to facilitate and encourage growth within our sport and recreation programs and facilities to provide active opportunities for all.

Every year the Shire receives funding requests from varied community groups to assist them with their projects. The intent of this fund was to streamline this process and ensure all groups receive an equal opportunity for funding, aside from the budget submission process which is usually for larger scale projects. Applying for financial assistance for smaller projects can often be very time consuming for the volunteers in committee roles and the Club Support Fund is a local opportunity, only open to incorporated clubs or associations within our Shire.

A total fund pool of \$12,000 was allocated in the 2015/16 budget, with clubs invited to apply for a grant of up to \$8,000. Applications were open for a month and closed on the 1<sup>st</sup> of April 2016. Shire staff have assessed the applications to ensure all meet eligibility requirements and the final decision is to be awarded by Council. Successful applicants will be required to acquit the funding by the 30<sup>th</sup> June 2016.

#### **COMMENT:**

Five applications were received for the Club Support Fund. All applications meet the eligibility requirements stated in the guidelines. The applications are attached with a summary sheet for Council to review and consider.

A total fund pool of \$12,000 has been allocated in the 15/16 budget, Council have discretion as to how this funding is awarded and how much of the fund is allocated. Once Council have selected the successful applicants, the Community Development Officer will work with the clubs to complete their projects.

Various independent sport & recreation planning consultants were contacted in January 2015 to provide a proposal to produce a Sport & Recreation Master Plan for the Shire of Mt Marshall. Tredwell Management, a specialist sport, recreation and open space planning and management firm, were successful in their proposal and engaged in February 2015.

The development of the plan was inclusive of all towns and locations within the Shire, to ensure all the needs and wants of clubs and associations were heard and considered in the development of the plan. Tredwell visited the Shire on three occasions to visit sport facilities, meet with clubs/associations and facilitate community workshops to gather as much information as possible. Tredwell also produced a survey for residents within the Shire and a club specific survey for all sporting and recreation groups.

Tredwell delivered a Draft Sport & Recreation Master Plan for Council to review prior to the July 2015 Ordinary Meeting of Council. At the July Ordinary Meeting, Council resolved the following:

#### **BACKGROUND:**

The Local Government Act 1995 requires a local government to prepare a review of the Approved Budget each year for consideration by Council. Council's annual budget review was presented to the March 2016 Ordinary Meeting.

#### COMMENT:

Since the 2015/16 Budget Review was prepared Council has adopted a revised road works program and staff have been doing some work on balancing overheads. Acting CEO, Eddie Piper, asked Consulting Accountant, Sue Voloczi, to prepare a revised Budget Review for Council information. Mrs Voloczi provided the following emailed comments on the Revised Budget Review:

#### Hi Eddie

I have reworked the Budget Review as discussed. I have attached a revised Budget Review and provide the following commentary by way of explanation. The spreadsheet, from which this pdf was published, is located on the file server at T:\ANNUAL DOCUMENTS\Budget\2015/16 BUDGET\Budget review 2015-16.

#### 1. Schedule 14 Over Recovery

- a. Reallocation of Talis Consulting review of Fair Value for Roads: the payment of \$60,602 to Talis on 11 August 2015 was originally budgeted and expensed as Schedule 04 Consulting Expenses on the basis that this was required in order to prepare the Statutory Accounts at 30 June 2016 with Roads at Fair Value. The data was used to bring the ROMANS data for the Shire of Mt Marshall up to date. On that basis, this can reasonably be treated as Engineering Consulting expenses and has been journalled to 1431191 Engineering Consulting.
- b. Labour Overheads Applied to Casual Staff: \$17,747 labour overheads had been charged over and above casual leave loading paid to casual staff. Of this, \$16,810 has been adjusted back against the cost codes originally charged in the Budget Review spreadsheet (but not put through

29

Synergy). This reduced the overhead recovery amount and reduced expenditure in a range of activities undertaken by outside staff.

- c. 40% of CEO Salary Applied to Works Supervision Costs: I have estimated this to be \$101,543 for 2015/16, and adjusted this amount from 0421011 Salaries Administration to 1431001 Works Supervision Salaries in the Budget Review spreadsheet (but not put through Synergy).
- d. Allocation of Schedule 04 overheads via Activity Based Costing (ABC): Tanika did some work on this before she went on holidays. To achieve the same result through Admin Allocations, we would need to double the Admin Overhead allocation to Public Works Overheads. The ABC approach (as applied in Local Government) dilutes the allocation of Schedule 04 Admin costs as the driver for this calculation is the proportion of full time equivalent hours regardless of the cost of individuals.

After adjusting as outlined above for Talis Consulting and CEO salary to be charged direct to Schedule 14, I have apportioned the remaining Administration Expenses in accordance with the percentages used in the original budget which include 9.59% allocated to 1431400 Public Works Overheads.

### e. Resulting Schedule 14 (Under)/Over Recoveries:

The Over Recovery in the previous Budget Review was \$171,000.

It is possible that a review of fuel allocations may result in a further recovery of Plant Operating Costs.

The original Budget included capital expenditure on Roads of \$2,245,379. Blackspot Funding of \$16,800 and associated expenditure of \$63,300 was not advised in time for inclusion in the original budget.

The increase in Roads Expenditure between the previous and revised budget reviews is \$126,777. I am proposing this is financed by:

- Increasing the amount deferred to 2016/17 by \$50,000 to \$90,000
- Reducing the contribution to Reserves
  - Bencubbin Aquatic Centre development \$34,000
  - o Plant Reserve \$40,000

The payout of Dirk, together with the recruitment cost of the new CEO totalling \$112,000 and the loss of \$64,000 budgeted Roads FAGS, go some way to reconciling the shortfall against the original budget.

#### 4. Bencubbin Rec Centre Redevelopment

In the previous budget review document, the Shire contribution of \$100,000 for design and calling of tenders was quarantined as a line item in the Rate Setting Statement "Held pending redevelopment of Rec Centre". This is now shown as budgeted Land and Buildings Capital Expenditure under GL Account 1193043.

#### 5. Bank Overdraft \$0.00

Towards June 2014, a Council Resolution had been passed to arrange a \$500,000 overdraft facility with BankWest. This was not progressed. Subsequently there has been discussion about moving the Shire's banking arrangements to Bendigo Bank.

If there is no advance payment of FAGS at the end of June 2016 (quite likely in view of the Federal Government's preoccupation with the pending election), there will potentially be some time when there is a significant squeeze on availability of funds. I suggest that action is taken to have an overdraft facility in place prior to 30 June 2016.

I think that covers the material issues for discussion. Please let me know if I can be of any further assistance.

- 2. authorise its voting delegates to negotiate if necessary on the above points 1 i), 1iii) and 1 iv).

#### **BACKGROUND:**

An MOU has been in existence since July 2011 and expires on 30 June 2016. This MOU has served its purpose, however with a new term there were several inclusions which need revision.

#### **COMMENT:**

A meeting of the KMPC was held on 12 April 2016 (agenda attached 12.4.6a) at which Council was represented by CR A Sachse (voting) and the Acting CEO, Eddie Piper (observer). At this meeting the existing MOU was discussed extensively in certain areas. The key points under discussion were:

#### Representation-

Whether there should be equal representation or based on contribution. The committee finally decided on equal representation, however reduced the voting delegates to one (1) only for Council.

#### Contribution-

Discussion centred on the following (excerpt from KMPC Agenda 12 April 2016):

- 1. The KMPC consist of three Member Councils, Trayning, Mt Marshall and Mukinbudin, each with a 33.3% share. Service allocation remain the same as they currently are. Nungarin are no longer a member Council. It is understood that Nungarin Shire Residents will continue to use the service in Kununoppin without any form of contribution towards the Practice.
- 2. The KMPC consist of four Member Council, Trayning, Mt Marshall and Mukinbudin, each with a 30% share and Nungarin with a 10% share. Each Member Council gets two representatives with the exception of Nungarin which has one representative. Medical Practice service delivery remains unchanged.
- 3. The KMPC consist of four Member Council, Trayning, Mt Marshall, Mukinbudin and Nungarin, each with a 25% share. Each Member Council gets two representatives. Medical Practice service delivery remains unchanged.
- 4. Status quo remains, The KMPC consist of four Member Council, Trayning 40%, Mt Marshall 25% and Mukinbudin 25% and Nungarin with a 10% share. Each Member Council gets two representatives. Medical Practice service delivery remains unchanged.
- \* In each instance Trayning administer the Scheme on behalf of the three or four member Councils as is currently the case.

#### Beacon Attendance

The GP appears to have indicated that he did not wish to attend Beacon as too much time was wasted with travel and the number of patients made attendance unsustainable. Council's representatives argued strongly and a compromise was presented that a six (6) month trial period be included with the GP reporting earlier if the visits were proving unprofitable. The Acting CEO and the Acting CEO of the Shire of Trayning are to discuss this with the GP.

Payment of Executive Services Undertaken by Shire of Trayning

The committee believed the Shire of Trayning should recoup the cost of executive services on an equal basis.

### Housing

At present it appears that no firm understanding of cost sharing of the supply of the house by the Shire of Trayning is in place. It was decided that a rental agreement between the Shire of Trayning and the KMPC be put in place to ensure a fixed charge with the Shire of Trayning absorbing all costs in relation to the maintenance and improvement of the house supplied.

Recommendation 2 is to allow Council's representatives to negotiate on the trial period of Beacon and the percentage contribution to the practice operations.

It should be noted that at the time of writing this agenda item the author cannot indicate the charge by the GP. The annual charge for 2015/16 was fifty thousand dollars (\$50,000). The cost of executive services by the Shire of Trayning and any cost in relation to the GP travelling from Bencubbin to Beacon are unknown at this stage. Allowance needs to be made in the 2016/17 Budget which could be substantially more than that of 2015/16 (\$40,000).

- SWIM 001 Notice on Non-Complying Private Swimming Pools The Head of Power has been changed to reflect current legislation under the Building Act 2011.
- FIRE 001 Approval to Burn Road Verges. This was sub-delegated to both Works Supervisor and Finance and Administration Manager. With Jack Walker now in the position of Regulatory Officer this has been changed to reflect the change in office.
- PROP 001 Acquiring or Disposing of Shire Property To A Value This is a new addition as previous Delegation Registers had not recorded Council delegating power to the CEO to acquire or dispose of Shire property.
