## FEDERAL ELECTION POLLING PLACES

You may have recently received a letter from the Australian Electoral Commission (AEC) advising that there has been a review of polling places throughout Australia.

As a result a number of polling places will not be operating in the coming federal election.

For your information the following towns will have a polling place:

You will note that Beacon no longer have a polling place. As a result of these polling place changes, you may be eligible to register as a General Postal Voter (GPV). As a GPV, you will automatically be sent ballot papers as soon as possible after the declaration of nominations for a federal election.

There are a range of criteria that may enable you to register as a GPV, including one that applies to a voter whose principal place of residence is more than 20 kilometres from a polling place.
