## WATERCORP UNMANNED AERIAL VEHICLE USE IN APRIL

In April the Water Corporation plans to carry out an aerial inspection of sections of Farmlands water pipelines using an Unmanned Aerial Vehicle (UAV), also known as a drone, so they can better identify problems and support future improvements.

The UAV will fly at an approximate height of 60 metres, to photograph both sides of the pipe. It may photograph up to 15 metres on either side of the pipeline, most of which is rural land and roads. It has an electric motor so makes very little noise.

Any identifiable personal information in these images will be obscured, and can be removed from the footage if requested. Images of private property can also be deleted on request.

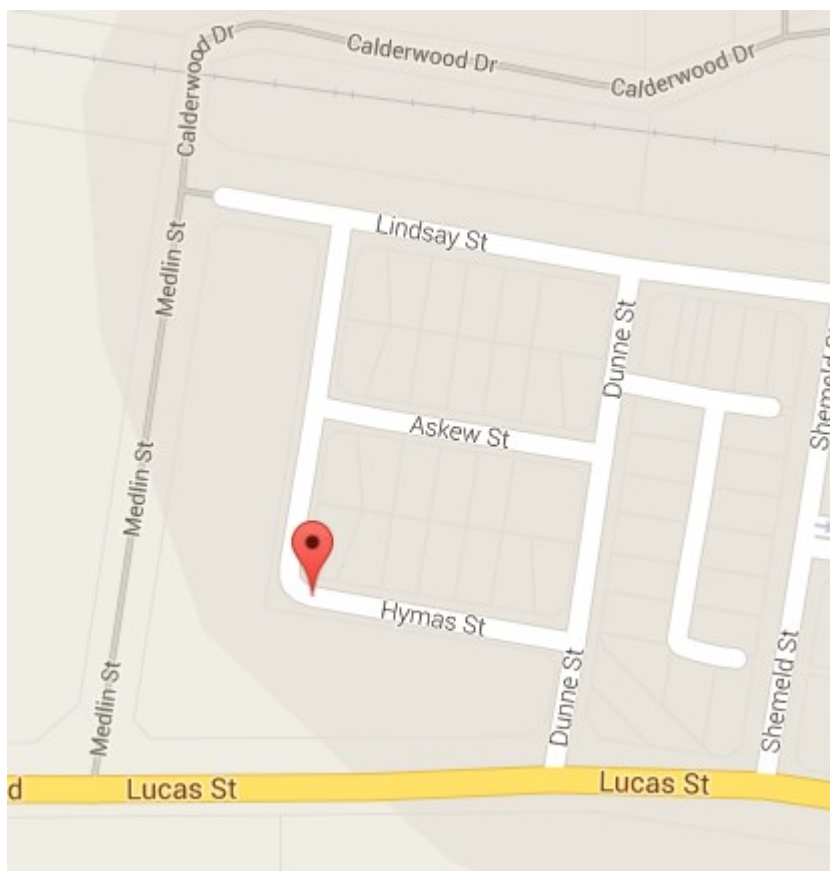
