PUBLIC NOTICE LOCAL GOVERNMENT ACT 1995

The Council of the Shire of Mt Marshall resolved on 14 February 2017 that it proposes to make the following local law:

Shire of Mt Marshall Extractive Industries Local Law 2017

Purpose: to prohibit the carrying on of an extractive industry unless by authority of a licence issued by the local government, regulate the carrying on of the extractive industry in order to minimise damage to the environment, roads and other peoples' health and property, and provide for the restoration and reinstatement of any excavation site.

Effect: is that any person wanting to carry on an extractive industry will need to be licensed and will need to comply with the provisions of the local law.

A copy of the proposed local law may be inspected at or obtained from the Shire of Mt Marshall administration office located at 80 Monger Street, Bencubbin between 9.00am and 4.00pm, Monday to Friday.
