The Beacon-Bencubbin Reconstruction is for the area commonly known as 'the causeway'. This will leave only a few small sections of shoulder widening left on this road.

The Final Seal of the Burakin-Wialki Rd will commence where the sealing finished in the 2011/12 financial year and go through to the rail crossing. This section has been reconstructed in parts and the remaining shoulder widening will be completed this financial year. It will not cover all of the area that is to be shoulder widened this year as the section will be too long to seal in one year.

The Final Seal on the Kellerberrin-Bencubbin Rd will complete the widening works on the Kellerberrin-Bencubbin Rd from the Koorda/Bullfinch Rd turnoff through to the shire boundary.

The Final Seal on the Beacon-Bencubbin Rd was included in the 10 year road program. It will run from the Beacon townsite through to where a final seal was applied in the 2012/13 financial year. This will leave significant sealing still to be completed.

The Final Seal/Reseal on the Koorda-Bullfinch Rd will be a section near the Lake McDermott turnoff which is starting to pothole and strip quite badly.
