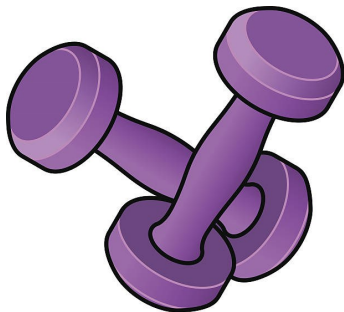
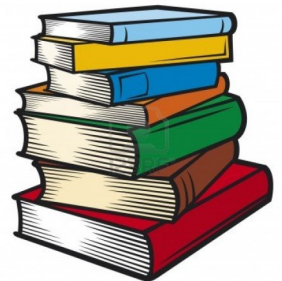


Shire Office - As of Monday 18 May

Bencubbin and Beacon Libraries - As of Monday 18 May

The Bencubbin Public Library will be open to the public, with the Beacon Library being open on a Thursday pending Beacon Central opening to the public. The Shire's Mystery Box program will finish up with Staff contacting members regarding the return of their outstanding boxes.



Bencubbin and Beacon Fitness Centres - As of Monday 18 May

Mt Marshall Aquatic Centre Redevelopment Project Update

Things are certainly looking a bit different at the Mt Marshall Aquatic Centre with the pool bowl full of bobcats, excavators and other machinery. Demolition of the existing pool bowl has been completed with earthworks to prepare the site being completed in the coming week. The redevelopment plans have been submitted to the Department of Health and we expect to hear back any day if they have been approved. Once these plans are approved the construction of the new pool will commence.
