LICENSING CLOSED




Please be advised that Department of Transport licensing services at the Shire office will be unavailable Wednesday 1 July 2020.

GYMS REOPENING

The Shire is pleased to announce that the Beacon and Bencubbin Gymnasiums are open once again. There are some conditions of use to ensure the facility is managed appropriately in regard to the current COVID-19 regulations.

All members are required to read and abide by the following conditions to ensure these facilities can remain open. If you have any questions, please don't hesitate to contact the Shire.



Cleaning

The Bencubbin and Beacon Gymnasiums will be closed between 7:00am - 8:00am Monday to Friday for cleaning as well as an additional clean on Friday from 3:00pm - 4:00pm. Allocating these set times ensures the Shire are meeting the cleaning requirements for the facilities.

Register of Attendance

All members are required to record their name, date and times of use on the provided attendance register. This register will replace the normal sign in register.

Alcohol Wipes

All members are required to utilise the alcohol cleaning wipes to wipe down any equipment they use, before and after use. Please let the Shire know if wipes need refilling at any stage.

Hand Sanitiser

Hand sanitiser has been provided for you to use, all members are required to use this on entry and exit of the gymnasium.

Number Restrictions

A maximum of 15 people will be permitted in the gymnasiums at any time.

COVID-19 Safety Plan
