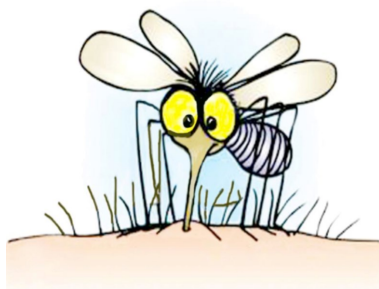

## MOSQUITO CONTROL

During late January and early February of 2021 the Shire will be carrying out a mosquito control measure at all townsite residences in Beacon and Bencubbin. An environmentally safe product will be introduced to the septic system of each residence, either directly or via the toilet. Toilet access will only be required should there not be direct access to the septic tank.

## **BUSH FIRE ACT 1954 PROHIBITED BURNING TIME**

All burning is prohibited in the Shire of Mt Marshall from Saturday 1 November 2020 to Sunday 31 January 2021. The Restricted Burning time will then continue until Monday 15 March 2021.

### **Burning to Protect a Dwelling / House**

Throughout the whole of the prohibited burning times, a fire break may be burnt to protect a dwelling house or other building, or a stack of produce. All the conditions of section 18 of the Bush Fires Act must be complied with including obtaining a permit for the burning. The burning may be carried out only between the hours of 4 o'clock in the afternoon and midnight of the same day as is specified in the permit, and within two plough or spade breaks of which the outer break is not more than 100 metres from the property to be protected.

### **Burning of Garden Refuse and Rubbish**

Garden refuse and rubbish may be burnt at any time, day or night, in a properly constructed incinerator designed to prevent the escape of sparks or burning material.

Garden refuse and rubbish burnt on the ground may be burnt only between the hours of 6 o'clock in the evening and 11 o'clock of the same day and must be completely extinguished no later than midnight on that day.

### **Firebreaks**

All landholders are reminded of the requirements relating to the provision of firebreaks. If your firebreaks do not comply with the Shire's Fire Break Order it may affect your insurance. Town site residents who have not complied will have received a letter from the Shire recently.

### **Camping and Cooking Fires**

All cooking, camping and open fires are prohibited during the prohibited burning time in the Shire of Mt Marshall. Wood or charcoal BBQ's and pizza ovens are permitted unless the fire danger index for the day is very high or above. Gas or electric BBQ's are permitted at all times. Permission can be obtained from the Shire to waive these conditions.

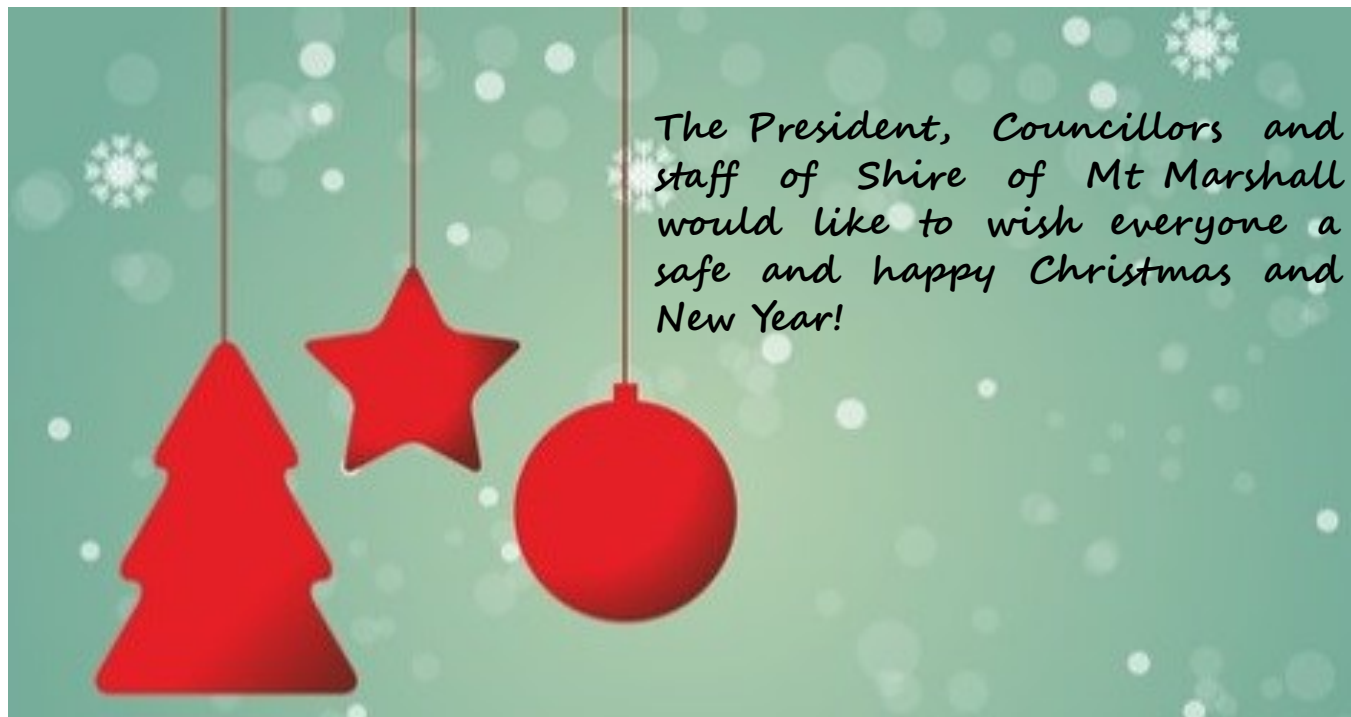
