## Background:

As part of the Mt Marshall annual budget for 2021/2022, Council continued the Economic Development Fund (EDF) with a total allocation of \$40,000.00. The fund is open twice annually for Community Groups and Businesses to make applications for funding of projects which benefit the community and promote economic development within the Shire of Mt Marshall. The first round saw 4 applications received totalling \$13,756.00

A Council appointed committee met on Tuesday 5 October 2021 to assess the applications. This item presents the applications, and the committee recommendation relating to each application. Also presented with this report are the minutes from the committee meeting.

As the applications contain both financial and sensitive business information it is not appropriate that they are presented as attachments to this item as they would then be open for public inspection. However, Councillors are able to view any and all of the documents in advance of the Council meeting.

### Relevant Plans and Policy:

Council adopted Policy CS3.2 (copy attached) relating to this funding.

### **Financial Implications:**

This year Council set aside \$40,000 to the fund, to be awarded over two rounds. The Committee is recommending awarding \$13,462.00 in this round.

### Risk Assessment:

There is a risk that if this funding were not available Council would be requested to fund projects without the necessary scrutiny and need for formal application, assessment and acquittal.

### **Community & Strategic Objectives:**

Governance and Leadership

Implement systems and processes that meet our legal and audit obligations and the needs of the community.

#### Comment:

The Economic Development Fund Committee met on 5 October 2021 and discussed the four applications at length. The minutes of the meeting are at **attachment 12.1.1a**. It is important to note that it will be a requirement for all grant money recipients to properly acquit the grant funding, and an amount less than awarded may be provided subject to the provision of receipts.

Listed below is information relating to each application and reasons for the committee recommendation.

### Bencubbin Sports Club – Shade Sail

Installation of a shade sail over the front courtyard area.

Sports Club is the central hub for social gatherings for many locals and visitors, expanding what they offer provides both community and economic benefit.

Upgrade to facilities and purchase of equipment fit the criteria for the funding.

### Beacon Country Club

Application didn't meet minimum request condition.

### Beacon Central

Kitchen upgrade – Required to be more user friendly and efficient for larger events, such as the wildflower tours. Providing a suitable area to store and prepare all food and drinks that are supplied on the wildflower tours. Bringing benefit to the volunteers who run the tours and currently prepare all food and refreshments in their own home. The Beacon Wildflower Tours were attended by 172 people this season, and it is hoped that if the tour continues to improve it will attract more visitors to our area. The upgrade will also make it possible for other events, meetings and so on to use the kitchen facility. \$20,304.00 to be funded by the Beacon Progress Association for the project.

## Beacon P & C Association

Purchase of equipment; a deep fryer to be used for catering at fundraising events such as sporting and community events. Economic benefits; generating money within the local community, supporting the school to achieve catering projects. The

equipment will also be available to use by other community groups for events. Letter of support received from Craig Lewington, Principal of Beacon Primary School.

### **Background:**

The Bush Fire Advisory Committee Meeting is held annually at the start of October. The committee is a Committee of Council and includes a Council representative, Bushfire Control Officers and Shire staff. The annual meeting is where Bush Fire Control Officers update the committee on any concerns regarding their particular area and recommendations may be made to Council by way of committee decisions. This item is seeking Council's receival of the minutes and their consideration of the Committee's recommendation made at the meeting held on Friday 1 October 2021.

### **Statutory Environment:**

Bush Fires Act (1954)

24F. Burning garden refuse during limited burning times

- (1) A person must not burn garden refuse at a place (other than a rubbish tip) during the limited burning times for that place unless it is burned —
  - (a) in an incinerator in accordance with subsection (2); or
  - (b) on the ground in accordance with subsection (3).

Penalty: \$3 000.

- (2) Garden refuse burned in an incinerator is burned in accordance with this subsection if
  - (a) the incinerator is designed and constructed so as to prevent the escape of sparks or burning material; and

- (b) either
  - (i) the incinerator is situated 2 m or more away from any building or fence; or
  - (ii) if the incinerator is within 2 m of a building or fence, the local government has given written permission for the incinerator to be used:

and

- (c) there is no inflammable material within 2 m of the incinerator while it is in use: and
- (d) at least one person is present at the site of the fire at all times until it is completely extinguished; and
- (e) when the fire is no longer required, the person ensures that the fire is completely extinguished by the application of water or earth.
- (3) Garden refuse burned on the ground is burned in accordance with this subsection if
  - (a) there is no inflammable material (other than that being burned) within 5 m of the fire at any time while the fire is burning; and
  - (b) the fire is lit between 6 p.m. and 11 p.m. and is completely extinguished before midnight on the same day; and
  - (c) at least one person is present at the site of the fire at all times until it is completely extinguished; and
  - (d) when the fire is no longer required, the person ensures that the fire is completely extinguished by the application of water or earth.
- 24G. Minister or local government may further restrict burning of garden refuse
  - (1) On the recommendation of the FES Commissioner the Minister may, by notice published in the *Gazette*, prohibit or impose restrictions on the burning of garden refuse that is otherwise permitted under section 24F.
  - (2) A local government may, by notice published in the *Gazette* and a newspaper circulating in its district, prohibit or impose restrictions on the burning of garden refuse within its district that is otherwise permitted under section 24F.
  - (3) A person must not burn garden refuse contrary to a prohibition or restriction imposed under this section.

Penalty: \$3 000.

- (4) In a notice under this section the Minister or a local government must specify
  - (a) the person or class of persons to whom; and
  - (b) the area in which; and
  - (c) the period during which,

the notice applies.

(5) The Minister or a local government may vary or cancel a notice under subsection (1) or (2) by publishing a further notice under the relevant subsection.

Although the author is not aware of any bush fires that have started from burning of garden refuse it is always a concern that it could happen.

#### Comment:

At the Bush Fire Advisory Committee Meeting held on Friday 1 October 2021, a recommendation to increase the restrictions on burning garden refuse was made. It recommended that restrictions on burning of garden refuse throughout the restricted burning period be increased to include a permit being required and restrictions on burning of garden refuse throughout the prohibited burning period be increased to include prohibition. This recommendation was carried by the Committee. There is currently no Shire policy for the burning of garden refuse and community members are required to abide by the legislation included in the Statutory Environment section of this item.

DFES Area Officer Daniel Hendriksen agreed with the recommendation that the restrictions on burning garden refuse throughout the prohibited burning period be increased to include prohibition however did not agree to permits being required to burn garden refuse during the restricted period.

The suggested amendments, and if appropriate reasoning behind the suggestion, are as follows:

## **ADMIN 1.5 Risk Management**

Minor change in 'operational guidelines' section. Council no longer Appoints the Auditors – this is done by the Auditor General – so wording change to 'receive' suggested.

### E&E 1.9 Staff Uniforms

Audit Partners have undertaken a different process. They have provided a document to be completed relating to fraud (see copy attached) but required that document to be signed by the Chief Executive Officer and the Common Seal to be appended. In order to avoid delay to the audit process the common seal was used (without prior approval) and this report seeks the retrospective approval of Council.

A local government may establish\* committees of 3 or more persons to assist the council and to exercise the powers and discharge the duties of the local government that can be delegated to committees.

- (a) to be a member of the committee; or
- (b) that a representative of the CEO be a member of the committee,

the local government is to appoint the CEO or the CEO's representative, as the case may be, to be a member of the committee.

- 5.11A. Deputy committee members
- (1) The local government may appoint\* a person to be a deputy of a member of a committee and may terminate such an appointment\* at any time.
- \* Absolute majority required.
- (2) A person who is appointed as a deputy of a member of a committee is to be —
- (a) if the member of the committee is a council member a council member; or
- (b) if the member of the committee is an employee an employee; or

#### Background:

In September 2021 the Shire received advice from the Department of Fire and Emergency Services that we were successful in the LGGS Capital Grant Round 2021/2022 for funding of a new Welbungin Bushfire Facility. The current facility is a one bay shed housing two appliances, with the Welbungin Brigade expecting a new, larger 4.4 broadacre fire appliance soon to replace the current 2.4 rural fire appliance. Having two appliances in a one bay shed causes an issue as the doors of the appliances are unable to be opened without making contact with the other appliance or the shed walls.

DFES Area Officer, Daniel Hendriksen recommended the Shire apply for funding of a new facility for Welbungin. He explained that if we were successful, we would not only be replacing the shed but also gaining a facility which included toilets and showers, a meeting room, office, washroom, changeroom and tearoom.

Funding of a new Bencubbin Brigade facility was applied for however this was unsuccessful. This facility was prioritised over a new facility for the Gabbin Brigade as the Shire is currently trying to source land for a new Gabbin facility. The Shire also noted in their application that they would look at applying for a new facility in Tampu in the next five years.

### Background:

Meg Wyatt the Shire's Regulatory Officer has provided her notice of resignation to the Chief Executive Officer. One of the roles of the position is dealing with emergency management including bush fire control.

One of the requirements of the Bushfires Act 1954 is that burning permits are required to be obtained at certain times of the year. Currently many of the local residents make a request for a permit to the Shire. The Chief Executive Officer is delegated by Council to be able to sign these permits, but once Miss Wyatt leaves on 8 November there will again be nobody else within the office who is authorised to sign. This means that on days when

the Chief Executive Officer is not in the office or available there is nobody who can provide a permit. This report therefore seeks Council's authority for Tanika McLennan and Lucia Scari to be appointed as a Bush Fire Control Officers – Permit Issuing Officers Only and therefore be able to grant and sign burning permits.

## **Statutory Environment:**

Bush Fires Act 1954

- 38. Local government may appoint bush fire control officer
- (1) A local government may from time to time appoint such persons as it thinks necessary to be its bush fire control officers under and for the purposes of this Act, and of those officers shall subject to section 38A(2) appoint 2 as the Chief Bush Fire Control Officer and the Deputy Chief Bush Fire Control Officer who shall be first and second in seniority of those officers, and subject thereto may determine the respective seniority of the other bush fire control officers appointed by it.
- (2A) The local government shall cause notice of an appointment made under the provisions of subsection (1) to be published at least once in a newspaper circulating in its district.

#### Comment:

Council is requested to consider this authorisation as appropriate pending the filling of the role of Regulatory Officer in order that the need to be able to approve and provide, or to reject, applications for a burning permit made by local community members can be fulfilled.

In relation to the officers who are recommended Ms McLennan has already received training in the role of Bush Fire Control Officers, and appropriate training in relation to the granting, refusing and preparation of burning permits will be provided to Miss Scari prior to the date that Miss Wyatt finishes her role at the Shire.

Should this recommendation be approved by Council the appropriate notifications in the local newspapers will be made as required by the legislation.
