Restricted and Prohibited Burning times

The "Restricted Burning Time" means the 19th September through until 31st October and the 1st March through until 31st March each calendar year (inclusive, and as varied pursuant to Sections 17 and 18 of the Bush Fires Act 1954).

The "Prohibited Burning Time" means the 1st November each calendar year through until 28th February the following calendar year (inclusive, and as varied pursuant to Sections 17 and 18 of the Bush Fires Act 1954).

Costs incurred by Gazettal of new fire break order.

Failure to make the changes will have the potential for a large fire within the shire, putting volunteers and the community at risk.

Comment:

At the Bush Fire Advisory Committee Meeting held on Friday 25 March 2022, a recommendation to change the restricted burning period to 1st March to 31st March annually was made. This recommendation was carried by the Committee. The current policy listed in the Fire Break Order states restricted burning period to end 15th March. Fire Break Order 2021/2022 is to be reviewed with changes to restricted burning times to be included.

DFES Area Officer Daniel Hendriksen agreed with the recommendation and confirmed that the restricted burning period can be brought forward by 14 days (17th March) or extended by 14 days (15th April) annually as per the judgement of the Chief Bush Fire Control Officer.

The Shire owns various pieces of land suitable for residential property construction across both Bencubbin and Beacon. Some of this land has been advertised as being available for purchase for several years through various channels, including on-line.

The administration staff were recently contacted by Mr Brandon & Mrs Krista Lancaster with an offer to purchase Lots 308 and 309 (8 & 10) Askew Street, Beacon. A copy of the letter is attached to this item.

The offer made is \$1000 per block and the letter explains what Mr & Mrs Lancaster intend to do with the land if their offer is accepted.

Statutory Environment:

Local Government Act 1995

- 3.58. Disposing of property
 - (1) In this section —

dispose includes to sell, lease, or otherwise dispose of, whether absolutely or not;

property includes the whole or any part of the interest of a local government in property, but does not include money.

- (2) Except as stated in this section, a local government can only dispose of property to
 - (a) the highest bidder at public auction; or
 - (b) the person who at public tender called by the local government makes what is, in the opinion of the local government, the most acceptable tender, whether or not it is the highest tender.
- (3) A local government can dispose of property other than under subsection (2) if, before agreeing to dispose of the property
 - (a) it gives local public notice of the proposed disposition
 - (i) describing the property concerned; and
 - (ii) giving details of the proposed disposition; and
 - (iii) inviting submissions to be made to the local government before a date to be specified in the notice, being a date not less than 2 weeks after the notice is first given;

and

- (b) it considers any submissions made to it before the date specified in the notice and, if its decision is made by the council or a committee, the decision and the reasons for it are recorded in the minutes of the meeting at which the decision was made.
- (4) The details of a proposed disposition that are required by subsection (3)(a)(ii) include
 - (a) the names of all other parties concerned; and
 - the consideration to be received by the local government for the disposition; and
 - (c) the market value of the disposition
 - (i) as ascertained by a valuation carried out not more than 6 months before the proposed disposition; or
 - (ii) as declared by a resolution of the local government on the basis of a valuation carried out more than 6 months before the proposed disposition that the local government believes to be a true indication of the value at the time of the proposed disposition.
- (5) This section does not apply to
 - (a) a disposition of an interest in land under the *Land Administration Act 1997* section 189 or 190; or
 - (b) a disposition of property in the course of carrying on a trading undertaking as defined in section 3.59; or
 - (c) anything that the local government provides to a particular person, for a fee or otherwise, in the performance of a function that it has under any written law; or
 - (d) any other disposition that is excluded by regulations from the application of this section.

Financial Implications:

There has been nothing budgeted this financial year for the sale of these pieces of land.

Risk Assessment:

Previous offers have been both accepted and refused by Council for other vacant land in the Shire. Previous refusals have been on the basis of the offer being too low (around the \$2000 to \$3000 mark) and/or that there was no serious intention to build on the land within a reasonable timeframe.

Community & Strategic Objectives:

Deliver sustainable long-term planning for infrastructure that meets the needs of the community

Comment:

The land in question has not been the subject of any previous offers that the administration is aware of. The amount offered is lower than that accepted for similar sized lots recently. The Shire would be required to obtain a valuation before any final decision can be made as required by legislation.

Should Council resolve that they are prepared to accept the offer made there would be a requirement for the offer to be put out for public consultation. This period would then allow Council to receive feedback from the community and take account of any comments or objections prior to a final decision being made by Council at a future Council Meeting.

 - (a) believes that the person is suitably qualified for the position; and
 - (b) is satisfied with the proposed arrangements relating to the person's employment.
- 5.39. Contracts for CEO and senior employees
 - (1) Subject to subsection (1a), the employment of a person who is a CEO or a senior employee is to be governed by a written contract in accordance with this section.

Background:

The current agreement with Avon Waste to provide waste services across the Shire expired some months ago. At the Ordinary Meeting of Council held in December 2021 Council authorised the service to be released for tender as required.

Only one response has been received and that is from Avon Waste. A copy of the full tender is available for inspection by Councillors should they wish to do so.

Background:

Rates and charges on A6370 remain outstanding, dating back to the 2019/20 financial year. The matter was first lodged with AMPAC, the Shire's debt collection agency on 20 November 2020. The following is a timeline of the events to date:

20/11/20 Letter of Demand issued

7/12/20 No response to letter of demand, AMPAC instructed to proceed to court

summons (General Procedure Claim GPC)

15/12/20 GPC sent for Service - ISWA

23/2/21 Bailiff attempted to serve and advised

"A6370 - 11859/2020 - SHIRE OF MT MARSHALL v MICHAEL JOHN WEDGE

I attended 88 BROWN STREET, BENCUBBIN and there was no response to the door on the 4 visits that have been made. On the first visit 18/12/20 we left a note in the front door and that same note was still in the same place in the front door on our final visit 20/2/20.

The front and back doors appear to have not been opened for quite some time, the bins are empty except for a newspaper dated July 2020 and there is no power running into the house (the metre is not moving). It would appear, that although there is furniture and other household items around the yard that the house is not currently occupied.

Our enquiries with the owner of KC's cafe in town and other locals indicate the subject died a few years ago of cancer. They further advised that they believed his wife was Leeanne Wedge but they weren't sure where she is.

Our searches confirm Michael John Wedge died on 29/9/2015 after a long battle with cancer he was survived by his wife Leeanne and children Anne, Shannon and Toni Wedge."

"The will is dated 16/08/2018 with Michael passing away 29/09/2015. He left his estate to Robert Martin Wedge of 46 Augusta St LAVERTON however under the will the property in question (88 Brown St) has been left to his wife Leeanne Rosslyn Wedge.

Given the above please advise if you are happy for us to send a demand to his wife Leeanne"

- 15/3/21 AMPAC instructed to send demand to Leeanne Wedge
- 9/6/21 Received the following from AMPAC:

"Michael and Leeanne Wedge A6370 – Legal action was issued against both parties but was unserved as the property is empty and Michael has passed away. We issued a probate for Michael who left his estate to his brother (Robert) but the property we are chasing was left to Leeanne. We issued a letter of demand to Robert and received and email from him advising that the estate had been closed off and the was no more money to pay any debts. Given that Robert was not responsible for the property and we have no address for Leeanne, we need to issue a skip trace against Leeanne so we attempt to serve her with the GPC. Please advise if you are happy to do so"

- 9/6/21 AMPAC instructed to conduct skip trace to find Leeanne Wedge
- 1/7/21 Results of skip trace received. AMPAC instructed to re-issue GPC to Leeanne Wedge at the address provided
- 22/7/21 AMPAC advised that Leeanne Wedge failed to respond within 14 days of being served. AMPAC instructed to proceed to judgement.
- 10/8/21 AMPAC advised "Judgment has been granted on this matter and they have failed to respond to the Judgment Letter".
- 10/8/21 AMPAC instructed to proceed to PSSO
- 1/9/21 Bailiff advised that there are no goods of value to be placed under seizure. AMPAC instructed to seize the property to settle debt.
- 10/1/22 Bailiff advised:

We have received a payment proposal from the judgement debtor partner/executor. I have included it below for your consideration:

"Good morning,

I Leeanne Wedge would like to make arrangements to pay the outstanding amount, in fortnightly payments of \$100. Starting on the Friday Jan 7th, by direct debit...

My reference is 250935...

I am on disability benefits, an can only afford \$100 per fortnight...

Im hoping you can help me...

Many thanks, Leeanne Wedge. "

10/1/22 Shire response:

"Whilst I am sympathetic to Ms Wedge being on disability benefits, unfortunately the proposal below will mean the current debt will take approximately 4 years to settle. This does not take into account annual rates that will be added during that time. On that basis, we cannot accept this offer."

- 31/1/22 AMPAC conducted rates, orders and requisitions enquiry in preparation for sale
- 2/3/22 AMPAC advised "We have received notification from the Bailiff that the auction is proceeding on Wednesday 23rd March 2022 at 2:30 pm at the address of 88 Brown Street, BENCUBBIN, WA 6477"
- 22/3/22 Various emails received from Rob Wedge, brother of Michael Wedge requesting further information about the property being auctioned, which resulted in Mr Wedge offering a payment arrangement:

"Unfortunately Leeanne doesn't tell me the entire story and I can understand the payment arrangement would not have been suitable, it would never have been paid. I can sympathise with any local government not receiving rates that are due.

Would the Shire consider \$1000 per month by direct credit and I'll pay it myself?

Thanks again and I apologise for the actions of Leeanne Wedge"

22/3/22 Emailed response from Shire:

"Thanks for your time on the phone earlier today and apologies it has taken some time to respond – we have been waiting for advice from our debt collection agents before I could make a final decision.

Unfortunately I have to tell you that the auction will proceed tomorrow (23 March) unless the debt is paid in full before the auction time (which I understand is 2.30pm).

Whilst your offer was a generous one (given you are not currently the owner of the property) regrettably at this late stage of the proceedings I am not able to accept it.

What I can say is that should the property be passed in tomorrow I would be happy to come back to you and look at ways in which we might be able to make arrangements to try to avoid a second auction taking place.

I know that this is not what you were hoping to hear so I can only thank you for your communication and wish you well – certainly should you have further queries I would be happy to try to answer them for you.

23/3/22 Mr Wedge advised:

"Further to our recent telephone conversation, I confirm that there were no registered bidders and the property was passed in at auction today. As a result, I am pleased to advise that the Shire is willing to accept your proposed payment arrangement of \$1,000 per month until the rates are brought up to date and accordingly I attach a reissue of the Rates Notice, which includes the Shire's bank details for you to set up the Direct Debit arrangement. If you could please advise what date you will be making the first payment I will then update the notes on this assessment to ensure no further legal action is taken whilst the payment plan is in place.

Please also advise if you would like the postal address updated on this assessment as I assume you will want future notices to come to you?

Thank you once again for your willingness to work with the Shire to get this matter resolved.

24/3/22 Mr Wedge paid first instalment of \$1,000 and asked:

"I would like the Shire to consider no more interest charges on the outstanding rates from today, I can understand the new rates collecting interest if I am late paying though."
