ROAD WORKS

The Works Crew is currently carrying out some clearing of blind intersections across the Shire. This is in preparation for the increase in heavy vehicle movements during harvest. If you know of any intersections that require some maintenance before the harvest period please contact the Shire office and provide details.

GRAIN CARTING

With summer approaching, grain growers have the option of using heavy vehicles on the Restricted Access Vehicle (RAV) road network to access CBH grain receival bins.

At present most of the Shire road network is rated to a RAV4 standard however a number of streets and roads are capable of taking heavier vehicles to a RAV5 and RAV6 standard.

They include:

Beacon Grain Bin Rd Beacon North Rd

Beacon-Bencubbin Rd
Ingleton Rd
Kirby St (Beacon)
Koorda-Bullfinch Rd
Mouroubra Rd
Probert Rd
Welbungin-Wialki Rd
Welbungin-Wialki Rd

In September 2015 the Shire applied to Main Roads WA (MRWA) to approve the use of the above roads to a higher RAV7 standard. RAV 7 approvals are expected to be announced by MRWA within the next month or so.

Under recently announced changes to the approval process, as of 1 September the Shire will no longer be the first port of call for heavy haulage approvals. Instead hauliers will need to apply directly to MRWA's Heavy Vehicle Section for RAV road approvals (see MRWA's Publications and Information website for details). The change is intended to speed up the approvals process.

As an aside, the Bencubbin CBH bin is limited by the exit at Watson Court onto Monger St which has RAV 4 status and is likely to remain so for the foreseeable future. This means that the Bencubbin bin is not capable of taking RAV6 or RAV7 vehicles.

REFUSE FACILITIES

Both Beacon and Bencubbin waste facilities have only a limited life and there is a great expense in both the closing and rehabilitation of the waste sites and the creation of new sites. There is also an expense with having to maintain the facilities and dig new trenches.

One way in which to extend the life of the tip and save ratepayer dollars is to correctly separate waste into the defined areas within the waste facility. Items such as steel and household furniture should not be disposed of in the household waste trench.

Staff have noted that not everyone is using the Shire's refuse facilities correctly. We would like to remind everyone of the following rules at both rubbish tips.

What can be accepted and where do I put it?

Household Waste Area

Anything that cannot be separated into one of the other areas Plus building rubble/cladding materials/masonry/pavers/tiles/timber Sheet glass, bottles, jars etc No furniture or mattresses

Car Bodies Area

*No car parts such as windscreens bumpers etc—these are to go into metal/steel area or household waste area

Asbestos Area

*Note—asbestos can only be accepted by appointment. Please contact the shire on 08 9685 1202 to book an appointment

Whitegoods / Electrical Appliances Area

All white goods
All electrical appliances
*Note—all whitegoods with refrigerated
gasses must be de-gassed before being
placed in the waste facility.

Green Waste Area

plants, cuttings, clippings etc.
Timber (scrap) and wooden furniture
green waste only—no plastic pots, steel
or waste of any other kind please

Wire & Metal Area

Wire/steel/metal sheeting
