STRATEGIC COMMUNITY PLANNING SURVEYS

We anticipate that rates notices will be distributed in early September.

CENTRAL EAST AGED CARE ALLIANCE (CEACA) SECURES FUNDING

The Shire of Mt Marshall has been a member of CEACA since 2012. CEACA is a partnership of 11 Wheatbelt local governments who will manage the development of 75 fully serviced and universally designed houses dedicated to the ageing population across the central and eastern Wheatbelt.

The project has received \$19.98 million dollars in Royalties for Regions (R4R) funding towards the CEACA project, of which the Shire of Mt Marshall will benefit. The Shire will be required to commit \$21,000 per unit for land preparation and \$60,000 per unit for the build, totalling \$81,000 per unit. The R4R funding will provide the balance. The project will deliver 3 Independent Living Units for the aged in the Shire over 2 stages.

Two units will be located in Brown Street, Bencubbin and one unit will be located in Askew Street, Beacon.

At its July 2016 ordinary meeting, Council resolved to make a local law relating to Health Amendment Local Law 2016.

CHANGE OF PURPOSE OF PLANT RESERVE

In accordance with section 6.11 (2) (a) of the Local Government Act 1995, Council resolved at its ordinary meeting, held 21 June 2016, to change the purpose of the Plant Reserve from:

“To fund the purchase of road construction plant, so as to avoid undue heavy burden in a single year”

To:

“To fund the purchase of plant which exceeds Council’s capitalisation threshold, so as to avoid undue heavy burden in a single year”
