Mt Marshall Shire Council and Chief Executive Officer, Dirk Sellenger have agreed to a mutual separation today with the CEO's contract to cease from close of business on Friday 26 February 2016.

Shire President, Rachel Kirby thanked Mr Sellenger for his contribution in advising Council and overseeing the operations of the Local Government's administration since his appointment in September 2014.

"Mr Sellenger has played an integral role in guiding our Shire's strategy and operations by providing a stable environment for staff and making several key staff appointments during his tenure. I would like to acknowledge Mr Sellenger's success in attracting significant grant funding to the Shire for the redevelopment of the Bencubbin Recreation Complex and his timely identification of the opportunity to construct a worker's camp," Cr Kirby said.

"Unfortunately, circumstances have led Mr Sellenger and the Council to mutually agree it is in the best interests of the community to bring about an early end to the employment relationship."

"On behalf of Council and our community I would like to thank Mr Sellenger for his commitment and contribution and wish him all the best for the future."

The Council today appointed Ms Tanika McLennan as Acting CEO from Monday 29 February 2016 until Wednesday 16 March 2016 or an Acting CEO from outside of the organisation can be recruited, whichever occurs first, to enable the recruitment of a new CEO to commence.
