



## INTERSECTION CHANGE - CLARK ROAD AND BURAKIN/WIALKI ROAD

Shire staff have been working on this intersection to replace the existing 'slip' roads with a T Junction as per the diagram below. Please take note of these important changes as the previous slip roads will be ripped up and made non trafficable. Works are now complete.
