SPEED LIMIT REDUCTIONS IN BEACON

After Council resolved to request Main Roads review and implement changes to the speed limits in and around both Bencubbin and Beacon, we are pleased to inform you that this has now been completed with the last of the speed limits implemented in Beacon. The implementation of speed restrictions and even the purchase and placement of signage is regulated meaning this was a task the Shire could not directly complete as this is a Main Roads responsibility. When driving in our towns please be mindful of the fact that 60km per hour zones have been reduced to 50km per hour and 90km per hour zones have been reduced to 80km per hour.
