**EXTERNAL YAGI ANTENNAS** have now been installed at both the Beacon Sporting Complex and the Beacon Caravan Park. People utilising both facilities will experience significantly improved mobile phone reception in the immediate surrounds along with internet coverage for supporting 'smart' phones.



The Shire's **SEPTIC TANK PUMP OUT SERVICE** will not be continued. As most will be aware from previous newsletters the waste truck has been non operational while awaiting repairs. There has been an increase in State government licensing requirements to carry out such a service including having a licensed and GPS trackable effluent tanker, a Dept. of Environment and Regulation licensed driver as well as a

licensed depot to dispose of the waste. These new requirements have made it not viable for the Shire to continue the service. The truck will continue to be used within our works department for various maintenance tasks.

The nearest licensed disposal depots are at Kununoppin and Koorda. If you require your septic to be pumped out, there are private operators in the area who can provide this service such as Barry Cummins of Trayning (0428 831 121). ## BENCUBBIN CARAVAN PARK WORKERS ACCOMODATION

Most of you will have noticed a lot of recent activity and additional structures at the Bencubbin Caravan Park. We provide community information regarding this project in summary below:

- Water Corporation (WC) informed the Shire in June of their Waddouring Tank project to be commencing in late July 2015 and projected to be completed in December . The project is a State funded \$6.3 million dollar project for the construction of a new tank at Waddouring. The project would be employing approx. 18 WC employees and assorted contractors.
- Waddouring Rock is located approximately 10kms south of Bencubbin however Bencubbin has very little accommodation available to offer the WC employees & contractors. The CEO has had lengthy discussions with the Water Corporation representatives and has obtained a commitment from the WC for fulltime accommodation between August and December 2015.
- A Special meeting of Council was held in June and Council resolved to allocate funds to the development of workers camp style accommodation. It is expected that the new accommodation will be beneficial long term in reducing the shortage of accommodation in Bencubbin. # Water Supply Improvements

Waddouring - July 2015

As part of the Water Corporation's commitment to improving water quality and supply to the Goldfields and Agricultural Region, we are installing a new 6 million litre water storage tank in Waddouring, along with associated pipework and valves.

The ground level storage tank will be located adjacent to the Waddouring Reservoir, on Water Corporation land, amongst vegetation.

A pressure control valve will be installed in the vicinity of Nungarin-Wyalkatchem Road in Trayning and will provide a more constant water pressure to Trayning. The project will improve water quality and service to the towns of Trayning, Bencubbin and surrounding farmlands.

## When is this happening?

Works are scheduled to begin in July 2015 and are expected to be complete around October 2016. Construction crews will be working within the Water Corporation site between the hours of 6.30am and 5pm, Monday through to Friday. Work may also be required between 6.30am and 2.30pm on Saturdays.

## How will it affect me?

As the tank works are contained within the revised boundary of the Water Corporation site, there should be no direct impacts on nearby properties. Very minor noise and dust may be experienced, however this will be kept to a minimum. There should not be any disruption to water services during the project.

Traffic management will be in place during the works, so drivers are encouraged to take care in the area.
