

EXPRESSIONS OF INTEREST SOUGHT — AGED CARE INDEPENDENT LIVING UNITS (ILU'S)

The Central East Aged Care Alliance (CEACA) is a partnership of 11 Wheatbelt Shires (Bruce Rock, Kellerberrin, Koorda, Merredin, Mt Marshall, Mukinbudin, Nungarin, Trayning, Wyalkatchem and Yilgarn) formed in 2012 and formalised as an incorporated association in mid-2015. CEACA Inc has the purpose of capturing economic benefit in the Wheatbelt by providing older people with the necessary services and infrastructure to remain living in their community. CEACA Inc's key area of activity is in the provision of appropriate housing options and public infrastructure that meets the needs of seniors. It is envisaged to have the potential in the future to provide health and home support services to residents within its communities.

As one of the member Shires, Mt Marshall is to have three units constructed within the first stages of the project. There will be two units built in Bencubbin (adjacent to the current ILU's on Brown Street), and one built in Beacon (on the current site of the Pioneer Park, Rowlands Street).




