As some will be aware the Beacon Barracks accommodation facility is currently managed by the Shire under a licence to occupy from the Public Transport Authority WA (PTA).

Unfortunately the Shire has been served with under notice that for licence early termination in June 2018 as the PTA are demolish to the Barracks Reasons include the potential for large financial out dealing lay with asbestos contained in the building.



The CEO is now investigating options regarding accommodation in Beacon once the licence terminates. The notice provides the possibility of the Shire taking over responsibility for the Barracks by application to the Department of Lands.


