#### WRITTEN SUBMISSIONS INVITED — BEACON BARRACKS

As some will be aware the Beacon Barracks accommodation facility is currently managed by the Shire under a licence to occupy from the Public Transport Authority WA (PTA).

Unfortunately the Shire has been served with notice under that licence for early termination in June 2018 as the PTA are to demolish the Barracks. Reasons include the potential for large financial out lay dealing with asbestos contained in the building.

The CEO is now investigating options regarding accommodation in Beacon once the licence terminates. The notice provides the possibility of the Shire taking over responsibility for the Barracks by application to the Department of Lands.



The CEO invites public comment on the future of accommodation in Beacon. What do you think the priorities and needs are regarding accommodation considerations? Would you see the need for replacement accommodation in Beacon, should the Shire not take responsibility for the Barracks? Submissions already received will be taken into consideration and there is no need to resubmit them.

#### NATIONAL GUN AMNESTY— 1 JULY TO 30 SEPTEMBER 2017

Australia's National Firearms Amnesty runs from 1 July to 30 September 2017.

The aim of the amnesty is to improve public safety by reducing the number of unregistered firearms and firearm-related articles in our community.

If you have an unregistered firearm, you may be able to register or sell it during the amnesty — no questions asked. If you cannot or do not want to register or sell your firearm, you can hand it in at an approved location. Your closest drop off locations are Wyalkatchem Police Station or Wongan Hills Police Station. If you are found in possession of unregistered firearms, you risk a fine of up to \$280,000, 14 years in jail and a criminal record.

#### TO ALL DOG OWNERS

Unfortunately, Shire staff continue to receive complaints with regards to dogs wandering around towns and causing a nuisance.

The Shire's authorised officers and rangers will be instructed to issue infringement notices to dog owners if complaints continue. Infringement Notices range from \$200.00 per offence and several offences may be committed by allowing your dog to wander at large. If it is necessary to impound your dog, further penalties will apply.

Exercising your dog without proper restraint, in the form of a lead, in public areas will also incur an infringement notice.

New residents to the Shire are encouraged to advise Shire staff if they own a dog which is licenced in another shire.

This notice is an appeal to dog owners to ensure their dogs are licensed, confined to yards or restrained appropriately when in public spaces. Your co-operation would be appreciated.
