BEACON INDUSTRIAL LAND

The Shire has been in discussions over the last few months with Landcorp regarding the possibility of the development and release of industrial land in Beacon.

Whilst Landcorp have not provided any guarantee that they would be able to financially commit to undertaking any development of industrial land in Beacon, they are wanting to gauge current interest. In order to do so they require confirmation by individual businesses that they have a firm interest in occupying newly developed industrial land.

In order to confirm interest the following questions must be answered:

- Name of business
- Type of business to be conducted on new land
- Size of land required
- What the business is willing to pay to purchase the developed land

GENERAL WASTE will be collected on **Sunday 23rd December** and **RECYCLING** will be collected on **Monday 24 December**.


Rubbish services will resume as normal during the New Year week
