## HAS YOUR CLUB REVIEWED ITS CONSTITUTION?

**Associations Incorporation Act 2015- The transition period is ending soon**

When the Associations Incorporation Act 2015 commenced on 1 July 2016 all incorporated clubs and associations were given three years to review and update their rules (commonly called a constitution) to make sure it complied with the Act.

***Just a reminder to all clubs that the transition period expires on 30 June 2019***

After 30 June 2019, if one or more of the Schedule 1 requirements are missing from your rules the relevant clause(s) from the Prescribed Model Rules will be deemed to be apply to your club.

To avoid the possible uncertainty this may cause, if you have not done so already please commence a review of your rules now. Consumer Protection's Transition Pack 3 is a step by step guide to help you review and update the rules to comply with the Act.
