The Shire has been approached by the Better Bencubbin Progress Association regarding erecting some native animal statues in Bencubbin, primarily along Monger St. The statues would be in various colours and made out of metal. The idea behind this request is that they would be of interest to visitors to the town.

We now invite feedback from the community as to whether you support the installation of these statues or not. Below is an example of the proposed statues:



Statues would be painted in bright colours eg yellow, orange, green and blue. Height of the statues will vary between 40cm and 4 ft.
