## FORMAL REQUEST FOR INFORMATION ON PRIVATE SWIMMING POOL AND SPAS

### Do you have a swimming pool or a spa?

All swimming pools and spas containing water greater than 300 mm (30 cm) must have a compliant safety barrier to restrict access to the pool area by young children (under the age of 5). This includes:

- In-ground pools and spas;
- above-ground pools and spas (including inflatable and portable pools and spas);
- Indoor pools and spas (but not spa baths that are normally emptied after each use); and
- Wading pools (containing water that is more than 300mm deep).

As a pool or spa owner, you have an obligation to ensure that you maintain the operation of your swimming pool or spa barrier to prevent access to the pool or spa.

The Shire of Mt Marshall is currently carrying out its round of required inspections for private swimming pools and spa barriers that are due to be re-inspected or inspected for the first time this year. Swimming pool barriers have to be inspected for safety and compliance and assessed against the Australian Standard AS 1926.1. Under Section 53 of the Building Act 2011 the Shire is required to inspect every swimming pool in the Shire, once every 4 years, to ensure safety is maintained to the currently adopted Australian Standard.

The safety of your pool or spa fence and gates at home is very important to your children and that of others who may access your pool.

### Building or Constructing a Swimming Pool
