BACKGROUND

On 30 March 2011 the Environmental Protection Authority notified the Shire that '...the scheme is defined as an assessed scheme'. This is in relation to the local planning Scheme and Strategy No 3 being submitted to the EPA for the required assessment. The Shire of Mt Marshall Local Panning Strategy and Local Planning Scheme No 3 was compiled and sent to the Western Australian Planning Commission (WAPC) which received the documents on 20 June 2011. A response has been received from the WAPC on 9 December 2011 stating that the Minister for Planning has given consent for advertising subject to the modifications attached.

COMMENT

Council is invited at the request of the Minister to adopt the changes as made by the WAPC and approved by the Minister for Planning to the Local Planning Scheme No. 3 and Local Planning Strategy as listed in the attachments.

The amendments proposed are essentially to re-format and update the documents (this event has been going on since 2006) requested by the WAPC and endorsed by the Minister for Planning. Should council *not* endorse all the changes then advertising of the Scheme cannot proceed.

Mr Bashall has indicated that there are no profound changes to the intent of the proposed Scheme and Strategy as originally endorsed by Council.

In the event that Council endorses both the Scheme and the Strategy the following will then be put into action:

- Local Planning Strategy as amended by the WAPC and Mr Bashall and if endorsed by Council a letter to that effect will be sent to the WAPC and the Strategy will be advertised for not less than 21 days as per Town Planning Regulations 1967 12A(3)
- Local Planning Scheme No. 3 as amended by the WAPC and Mr Bashall and if endorsed by Council a letter to that effect along with the modified Scheme will

be returned to the WAPC for final review and they will place a notification into the Government Gazette approving advertising for a period of not less than three (3) months

In both cases the Scheme and Strategy can be advertised in a local newspaper circulating within the district.

Further to the above the local planning policies can also be considered for adoption by Council and then be subject to advertising of not less than 21 days. The policies can be endorsed into the Scheme only when the Scheme is gazetted.

- 3. After 82 days from the serving of the demolition notice that the principal Environmental Health Officer/Building Surveyor inspect Lot 10 Hammond Street Gabbin to determine compliance with the demolition notice.

BACKGROUND

At the July 2009 Ordinary Meeting of Council following receipt of a complaint regarding the condition of the dwelling located at Lot 10 Hammond St Gabbin, a report was presented for Council consideration and Council resolved that a work order be placed on Lot 10 Hammond Street Gabbin with a period of 90 days given to complete the work. The owners of the house, Mrs GM Trainor, were notified of the decision by Notice served on Mrs GM Trainor by registered post on 14 October 2009. No work pursuant to the Notice issued had been performed on the house from the date the Notice had been served to present which totals 26 months.

At the March 2010 Ordinary Meeting of Council information was received that the building was still declared unfit for human habitation and that the schedule in the Notice had not been accomplished therefore quotes for the demolition of the dwelling were to be sought.

An expense for the demolition of the house was placed in the 2011/2012 budget. A demolition licence was approved on 19 August 2011 and a contractor engaged for the demolition on 22 August 2011. A letter notifying Mrs Trainor of the demolition was sent on 16 August 2011 and received by Mrs Trainor on 26 August 2011. The letter was to give Mrs Trainor two weeks notice of the demolition.

Consequently Mrs Trainor approached the State Administrative Tribunal and through lawyers came to an agreement with the shire that the house would not be demolished on reliance of the Section 139 notice. Legal advice received by the Shire indicated that a demolition could not be actioned as only a reference to a 'Work Order' was in written correspondence. The works to demolish the dwelling were thus cancelled in this instance. Legal advice to the Shire is that the necessary procedures to condemn the house is to use section 137 of the *Health Act 1911* to gain authority to demolish the house.

Chief Executive Officer Matthew Gilfellon advised Mrs Trainor that the EHO/BS (the author) intended to inspect the dwelling on 29 November 2011 and invited her and/or her agent to be present.

COMMENT

On 29 November 2011 the CEO and the author met with Mrs & Mr Trainor along with her daughter Kate at the dwelling and an inspection was carried out. Mrs Trainor mentioned that an independent building inspector had been arranged to inspect the house within four weeks.

The dwelling was inspected inside and out and the following observations made:

- Dwelling has been cleared of miscellaneous items from all rooms which allowed for a more complete inspection of the floors previously covered.
- Bedrooms on west side of dwelling displaying evidence of termite activity in floors (see pictures 1, 4, 5, 6, 7, 8, 9, 10).
- Ceiling in kitchen collapsed exposing termite damaged roof members (see pictures 11, 12).
- Holes in wall (see picture 13).
- No floor coverings in bathroom & laundry (see pictures 14, 15).
- Outside walls with cracks (see pictures 16, 17).
- Outside walls cement fretting (see pictures 18, 19, 20, 21).
- Gutters damaged and filled with matter (see pictures 22, 23). Also observed was numerous missing and/or damaged downpipes.
- Hot water system at rear of property non-functioning.
- Doors to the outside damaged and shored up by furniture (see picture 3).
- Rear patio semi collapsed and termite damaged with exposed asbestos (see picture 24, 25, 26, 27).
- Floor stump termite damaged (see picture 28).
- Pot Belly flue hole in ceiling & roof exposed to the elements.

- Septic non-functioning and leech drains damaged and collapsed (see pictures 29, 30).
- Interior of walls cracked and in places sections missing (see picture 3a)

Overall the condition of the dwelling is poor and would require a substantial investment to return to a condition which would permit habitation. Mrs Trainor has indicated that an independent building inspector has been engaged to inspect the dwelling 'within a month' from the note given to the EHO/BS (author) on 29 November 2011.

Following discussions with the Department of Health, it became apparent that there exists a failure to comply with a notice served under the *Health Act 1911* Part V 'Dwellings Division 1 Houses Unfit for Occupation' and this constitutes an offence as detailed in the *Health Act 1911* Part V Dwellings Division 1 Houses Unfit For Occupation section 140 (1) Local Government May Act In Default Of Owner. The Shire of Wyalkatchem has successfully prosecuted for such a failure when the late Mr Neil Flood the then EHO/BS was employed. The Department of Health has advised that the *Health Act 1911* provisions on this matter need to be followed through.

BACKGROUND:

I was contacted by Mrs Deanne Breakell, President of the Bencubbin Parents and Citizens Association (P&C), asking about options for purchasing new starting blocks for the deep end of the pool. I worked with Mrs Breakell to get some quotes.

A letter was received from the Bencubbin P&C in regards to purchasing removable diving blocks to be located at the deep end of the Mt Marshall Pool. As the depth here is in excess of three (3) metres, there are no restrictions on diving blocks. Attached to the correspondence were signatures from both Bencubbin and Beacon parents in support for the new starting blocks and a quote for how much they will cost.

The lack of starting blocks are seen as a disadvantage to swimmers in regards to records as they are not entering the pool from a platform. The Mt Marshall Swimming

Pools host the Mt Marshall Swimming Carnival each year as well as the Dampier Interschool Sports Association (DISA) swimming carnival two (2) out of every five (5) years. Mt Marshall is the only swimming pool that does not have starting blocks that are used at the DISA swimming carnival

The existing Mt Marshall Swimming Pool was built in 1976 and opened for business in the last week in November of that year. In 1976 there were very few recommendations in place for the safety of patrons in regards to signage, depth markings, diving depths and more. Throughout the 1980's recommendations were developed by the Royal Life Saving Society which are continually updated to ensure patron safety. Although they are only recommendations, they are recognised by the courts in the case of an incident. The most recent Council in Western Australia to be found negligent in regards to diving blocks is Port Headland (see attached article).

The current dive blocks located at the shallow end of the Mt Marshall Swimming Pool have not been used for about fifteen (15) years as the depth of water is too shallow (1.2 metres). The dive blocks are a major risk as there is nothing to stop people using the blocks, only signage and education of the local children and patrons. It also means that the Swimming Club and at swimming carnivals there are no blocks that can be used for the starting of races.

COMMENT:

I feel that Council need to consider the removal of the existing starting blocks at the shallow end of the pool and replace them with removable blocks at the deep end of the pool. I recommend the purchase of removable blocks as they can still be incorporated into any pool upgrades that may happen at the pool in future years.

Although the current starting blocks are sign marked 'NO DIVING' and we have educated local patrons on their prohibited use, it does not eliminate the potential risk of the current starting blocks creating an incident. Looking at past case studies it is not enough to protect council from being found negligent.

In total the cost purchasing new starting blocks is \$7812 (excluding GST). You would also need to allow \$2000 to fit the braces that hold them in place. I have recommended several options below for Council to consider.

In the current budget there is \$17,000 allocated for the septics at the Old Pavilion (gym and visitor change rooms) at the Bencubbin Recreation Grounds. Council may choose to remove this project from the budget and funds could be reallocated for the purchase of the new starting blocks. Being that there is \$17,000 in this account, there would also be enough funds to be able to remove the existing dive blocks.

Another option would be for the funds for the purchase and installation of the new starting blocks from Council Swimming Pool Reserve. The money for the removal of the existing blocks could also be taken from this reserve.

The final option I present is that the funds for the purchase of the new starting blocks be considered in the 2011/2012 budget review in February and that the funds for the removal of the existing starting blocks be considered in the 2012/2013 financial year budget.

It is now at the stage that in order for the debt to be repaid legal again will need to be commenced. This can be expensive as first a trace must be performed to find a physical address and then legal action commenced.

Advice from Dun & Bradstreet is that often courts take sympathy on a person representing themselves and even though we may wish to stand on our principles, it can be expensive to do so.

Cr MP Hogan declared he held an impartiality interest in the matter due to his association with the applicant Carbon Conscious, and read aloud the disclaimer.

BACKGROUND:

In 2002 the Better Bencubbin Progress Association appointed LG Crothers of LG Consulting Services to develop a business plan for the establishment of a Rural Transaction Centre in Bencubbin. The total establishment costs of the proposed facility were \$570,600.00. The plan was never implemented but several other options were considered. These include the modification of the Bencubbin Community Hall, transportable dongers, use of the Seventh Day Adventist Church Building and more. None of the proposed plans to improve the facilities of the Bencubbin Community Resource Centre were feasible at the time.

In 2007, the Shire Community Development Officer met with the Bencubbin Community Resource Centre Committee to facilitate a strategic planning workshop. It was determined here that the issue of limited space was still a concern for the Committee. The main concern being that the limited area was restricting the services that could be delivered to the community. The same issue has also been raised at community meetings such as the plan for the future workshops in 2006.

In December 2010, the Shire developed a Forward Capital Works Plan (FCWP) after being allocated funds through the Country Local Government Funding (CLGF) program administered by the Department of Regional Development and Lands (DRDL). The FCWP aimed to identify how Council would expend the CLGF allocation. Community consultation was held to establish any infrastructure needs important to the community. The construction of a Bencubbin Community Centre Building to house the Bencubbin Community Resource Centre was nominated at the highest infrastructure priority by the Bencubbin community. Within the FCWP, the Bencubbin Community Centre building was included in the first year of the five year financial plan. This meant that plans needed to be developed in the 2010-2011 financial year ready for the construction of the building in 2011-2012. In consultation with the Bencubbin Community Resource Centre and The Gimlet Newspaper, basic floor plans for the building were developed in 2010/2011 by Design Synergy.

When developing the project plan for the project, a detailed costing on the building was considered necessary. This included the development of a reasonably accurate budget. Building companies state-wide were invited to submit an expressions of Interest (EOI) for the construction of the building. Expressions of Interest submissions were received from Rosemark Pty Ltd, ICS Carpentry and Bricklay Pty Ltd. Using the three (3) EOI submissions, a budget amount was developed to be included in the project budget. Once the project plan was completed in July 2011, funding applications were submitted to the Department of Regional Development and Lands (Regional Collocation Funding Program) and Lotterywest (Community Buildings).

An EOI is the first stage of a two-stage process. Following the close of the EOI, Council may proceed to the calling of a restricted Request for Tender (RFT). Eligibility to participate in the restricted RFT will be limited to providers who comply with the selection criteria of the EOI and who are accepted by Council to be placed on a qualified shortlist.

The issuing of an EOI does not commit Council to proceeding with an RFT. The submission of an EOI does not commit Council to include any organisation on the shortlist in the event that the project proceeds. This means that a RFT does not have to be restricted and can be advertised state wide.

In November 2011, the Shire was notified that their application for \$129,000 through the Department of Regional Development and Lands (Regional Collocation Funding Program) was successful. A second application for \$260,000 through Lotterywest (Community Buildings) is still awaiting approval.

The 2011/2012 budget allocations for the project include the following:

Funding (Regional Collocation Funding Program) \$125,000

Royalties 4 Regions (R4R) 2010/2011 allocation \$242,092

Royalties 4 Regions (R4R) 2011/2012 allocation \$175,472

Council Funds \$ 57,436

This makes a total allocation of:

\$600,000.

We have been informed that the 2011/2012 R4R allocation can be spent prior to the 2010/2011 allocation being acquitted. This will allow us to use both of the allocations if required. The current budget allocation does not include the \$260,000 grant funds that have been applied for through Lotterywest. If the Lotterywest funds are approved, the \$57,436 of Council Funds and the \$175,472 of the 2011/2012 R4R allocation will not be required to complete the project.

Once the Shire receives notification of the outcome of the Lotterywest funding application, tenders would need to be called to be able to appoint a builder to construct the building. It is hoped that we will be notified by late December 2011 or early January 2012 as to the success of this application.

COMMENT:

The Shire has already called for Expressions of Interest from building companies, therefore they can choose to hold a RFT or a restricted RFT for the construction of the Bencubbin Community Centre. A RFT would be advertised in the West Australian and be open to any building company to submit a tender. A restricted RFT involves inviting only the companies that submitted acceptable Expression of Interest document to submit a tender.

I recommend that Council proceed with a restricted RFT and invite the three companies, Rosemark PTY, ICS Carpentry and Bricklay Pty Ltd to tender for the construction of the Bencubbin Community Centre. By calling for the Expressions of Interest, I believe the Shire has already gauged the interest from building companies state wide to take on the construction of the building.

I have summarised all three of the expression of interest submissions received to ensure each of the companies have met the selection criteria outlined in the request for EOI document.

In reference to Council Policy Admin.1.7 – Advertising and Receiving Tenders, the opening of the tenders are to be done in the presence of one (1) Councillor and, if possible, two (2) Officers. I ask that Council appoint a Councillor to be present for the opening of the tenders. Opening of the tenders is planned to happen in the first week of February.

That costings for the resurfacing of the Beacon netball court be investigated and a report be presented to the February Ordinary Meeting of Council.

BACKGROUND:

The resurfacing of the Beacon Netball Court was included in the 2010-15 Forward Capital Works Plan. Originally it was allocated \$30,000 and was scheduled to be completed in the 2014/15 financial year.

On May 17 2011 an email was received from the Beacon Netball Club asking that the resurfacing of the netball court be considered in the 2011/12 budget. The quote that the netball club had received for resurfacing of the court was \$30,000. The netball club advised that they had \$10,000 to contribute and would apply for \$10,000 funding through CSRFF funding. The shire would need to contribute \$10,000. It was considered but was not included in the budget due to its priority place in the Forward Capital Works Plan.

Leading up to the budget, the Chief Executive Officer and Shire Engineer worked with the Beacon Netball Club regarding the surface cracking issue. The \$30,000 would cover the cost of resurfacing the Netball Court but this may only be a short term solution to the cracking. Another proposed solution would be to create a new base and resurface one of the current basketball courts so that it could be used as a dual purpose court. This would also solve the basketball court cracking problem and allow lower cost resurfacing in the future. It was estimated that this would cost \$60,000. An additional amount may be required for the relocation of the shelter and fence.

On 5 October 2011 an email was received from the Beacon Netball Club advising that the court had gone downhill quickly during the year and that they expected that the association would have issues with the court in the following season. The email also mentioned that they would be happy with a dual purpose netball/basketball court. This was discussed with council along with the problem that it was a low priority in the forward capital works plan.

The Forward Capital Works Plan was presented to the Ordinary Meeting of Council in November where it was decided to conduct a review of the Forward Capital Works Plan in February/March 2012.

On 9 December 2011 an email was received from the Beacon Netball Club asking what the most viable way was to get the project happening. The Chief Executive Officer replied that the best way would be to talk to councillors and get approval from Beacon Progress Association for the Netball Court to be listed higher on the priority listing. A letter was received on 15 December 2011 stating that the Beacon Netball Club had support from Beacon Progress Association and asking that the issue be taken to council.

COMMENT:

This project would qualify for the CSRFF Small Grants Program which if successful would provide one third funding for the project. This funding is available twice per year. The next round will be advertised in February, with the application going to the March Meeting of Council and the application submitted at the end of March. Applicants would be notified of the application outcome in May 2012.

BACKGROUND:

On 16 December 2011, two emails were received from the Shire of Trayning regarding upgrades to the Kununoppin Airstrip and seeking possible assistance from the shires in the Kununoppin Hospital catchment.

The first set of upgrades will entail an apron seal extension, resealing a section of the for drainage improvement, and runway remove replace existing runway/taxiway/threshold aviation lights and to get a generator installed at the terminal for an emergency power source. This is a total project cost of \$93,500 though the lighting is unlikely to proceed which will reduce the project to \$63,500. These works will be applied for under the Regional Aviation Access Program (RAAP) and the Regional Airports Development Scheme (RADS). Both of these grant schemes require funding from each party but if both grants are successful then each party will provide one third funding. The Shire of Trayning proposes that the shire contribution

be split using the same formula as the Kununoppin Medical Practice expenses. This would leave the Shire of Mt Marshall with a contribution of a maximum of \$11,687 for the full project or for the smaller project a maximum of \$7,938 and a minimum of \$5,292.

The second upgrade involves having the paperwork and details of a GPS approach to Kununoppin Airstrip prepared and for the documentation to then be included in the pilots handbook. This page assists pilots in making approaches in bad conditions or at night. The cost of doing this is estimated to be \$100,000. This will be applied for under the RADS program. A contribution from the Shire of Mt Marshall of \$12,500 would be required.

COMMENT:

If both projects are successful then the Shire of Mt Marshall could require a contribution of around \$20,000 but up to \$24,000. Niel Mitchell indicated that without the support of the shires in the Kununoppin Hospital catchment, it was unlikely that the second upgrade would go ahead.

There will be money in the NEWROC expense account as the NEWROC Engineering Technical Officer position did not go ahead.
