Approval for the increase in the number of movements from an average of 2.5 to 4 movements a week providing this increase incorporates the increase in product from the revised blasting operations, however the waste rock used around the pit or stockpiled should be returned to the pit on completion of the quarry operations, with the overburden returned as the final level to best return the resulting useable land for farming.

That the respective management plans required in the Council's approval be revised/or prepared to incorporate the Council's requirements for the variations requested in this item.

BACKGROUND:

In August 2014 the Council issued a Planning Approval for an extractive operation on Avon Location 15112 Luckman Road about 1 kilometre north east of Welbungin Townsite.

The proposal was to develop a primary crushing system, a secondary crushing system and an area for stockpiling various aggregate sizes.

The proposal stated that minor service and maintenance to infrastructure would be conducted on-site and all other repairs and maintenance of infrastructure will be conducted at the company's Whittle Road facility.

Whitestone Quarries Pty Ltd is now requesting variations to the current proposal to which the existing approval relates.

PROPERTY LOCATION

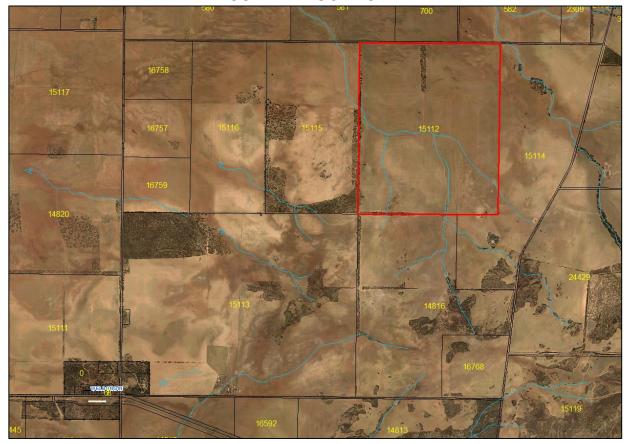


FIGURE 1 - LOCATION PLAN

The extractive operation is located in the south east corner of Avon Loc. 15112 Luckman Road as shown in **Figure 1** with access to the site from Luckman Road on the northern boundary.

THE SCHEME

The land is zoned 'Rural' under the Shire of Mt Marshall Town Planning Scheme 3 in which an extractive industry is a 'D' (discretionary use) use in Table I – Zoning Table of the Scheme.

PROPOSED VARIATIONS

The proponent has requested that Council acknowledge the following variations to the original proposal;

a) The **number of vehicle movements** from 126 loads per year to 200 per year. This change is not in volume of material but a miscalculation of the trucks' capacity which was based on 79 tonnes instead of 50 tonnes.

Comment: This change will lessen the vehicle impact on the surrounding road surfaces due to smaller payload, however it will increase the truck movements by an average of 1.5 movements per week (from about 2.5 to 4 movements per week).

b) The **frequency of blasting** has been altered from 4-6 week cycles producing a maximum of 10,000 tonnes per annum. Blasting is now expected to be carried out 2-3 times per year generally producing between 2,000 and 6,000 tonnes per blast.

Comment: This variation is significant in volume – from 10,000 tonnes per year to a potential of 18,000 tonnes per year, however the main impact will be the vehicle movements (discussed above).

c) **Waste rock** will **not** now be carted back to the pit. The bulk of the waste will be used to form a bund around the pit before fencing. Excess overburden may be carted back to the pit to return as much agricultural land as possible.

Comment: Forming a bund around the pit will only exaggerate the visual impact of the pit and make it more difficult to rehabilitate on completion of the operations. It seems unnecessary to form any significant bund in order to fence the pit. It is acknowledged that the final impact on the property will be a depression as the saleable product will have left the site, however the resultant depression should be minimised as much as possible allowing maximum area to revert to farming land.

d) The applicant sees no need to **revegetate the area** on completion of the project as there is no existing vegetation. The operational areas are shown in **Figure 2**.

Comment: The areas shown in **Figure 2** have been derived from the applicant's sketch. Although the areas are approximate it shows that there is over 11 hectares designated for stockpile and processing, with an additional 0.76 hectares for machinery maintenance. These areas should be rehabilitated with topsoil to provide for continued farming on the completion of works.

CONCLUSION

The variations outlined in the applicant's submission have presumably surfaced through refinements in the extraction processes and operations.

In conclusion, it is suggested that the increase in the number of movements from an average of 2.5 to 4 movements a week is not significant if it incorporates the increase in product from the revised blasting operations.

Waste rock used around the pit or stockpiled should be returned to the pit on completion of the quarry operations, with the overburden returned as the final level to best return the resulting useable land for farming.

COMMENT ON CURRENT APPROVAL STATUS

Condition e) of the Council's approval issued in August 2014 required;

Within three (3) months of planning approval that an

- 'Operations Management Plan',
- 'Environmental Management Plan (which is to include a Waste Management Plan, Water Management Plan, Dust Management Plan and Noise Management Plan),
- 'Traffic Management Plan',
- 'Rehabilitation and Closure Plan' and a
- 'Dewatering Plan'

to be submitted to the Shire of Mt Marshall and to be approved by Council.

Council's records indicate that an Environmental Management Plan, Dust Management Plan, Noise Management Plan, and a Rehabilitation and Closure Plan have been submitted but the Council is still awaiting a Waste Management Plan, Dewatering / Water Management Plan and a Traffic Management Plan.

The CEO believes additional accommodation by way of transportable accommodation situated at the Beacon Caravan Park would be considered a more suitable accommodation

arrangement long term given the age of the Beacon Railway Barracks and the fact these are not an asset of Council.

Following is an advert for some used transportable buildings which the CEO believes would be suitable for the future accommodation requirements with a large number of "worker / tradesman" type accommodation sought in the area.



More research needs to be done prior to committing to any purchases including the following:

- Inspection of the used units
- Determining available area to accommodate the building on site
- Determining existing utility availablity (Electricity, Water)
- Determining cost to connect utilities to unit.
- Sewerage requirements. (tap into existing or new system)
- Determing cost for relocation and installation in Beacon.
- Cost of verandah and landscaping
- Costs to fit out with TV, bedding, aircons etc.

In the event the Shire was to proceed with the purchase and installation of the transportable building the intention would be that the Shire would cease to be responsible for the Beacon Barracks. The Shire would seek to cease any and all involvement with the Beacon Barracks and these could be returned to the owners or advertised for an interested party to take over this responsibility from the Shire, should the existing lease arrangement allow for this to occur.

 - (a) the supply of the goods or services is to be obtained from expenditure authorised in an emergency under section 6.8(1)(c) of the Act; or
 - (b) the supply of the goods or services is to be obtained through the Council Purchasing Service of WALGA; or
 - (ba) the local government intends to enter into a contract arrangement for the supply of goods or services where —
 - (i) the supplier is either
 - (I) an individual whose last employer was the local government; or
